

Festive Carnival (“Promotion”)

**Date: 12 March to 30 April 2021 (both dates inclusive) (“Promotion Period”)**

Promotion:

1. This Promotion is exclusive to CapitaStar Members (referred to as “Eligible Shopper”). All shoppers can download the CapitaStar mobile application and sign up within the App as a CapitaStar member to qualify and participate in this Promotion.

2. For ease of reference, the simplified Promotion Mechanics are set out in the table below to qualify for the Festive Carnival rewards. Rewards comprise of eCapitaVoucher and Car Park Coupon (“Reward”) according to the table below.

**Spend and Redeem** – To qualify for the Spend and Redeem Reward, Eligible Shoppers must spend a minimum of S\$100/(\$120 with supermarket receipts) at SingPost to get \$10 eCapitaVoucher. Limited to first 6,000 redemptions. Limited to 1 redemption per CapitaStar Member per day. Not valid for receipts from enrichment tenants.

**Free Parking (worth \$3.33)** – To qualify for the Free Parking , Eligible Shopper must spend a minimum of \$50. Limited to 1 redemption per CapitaStar Member per day.

**New Member Perks** – Sign up as a new CapitaStar member with Promo Code (SPCREWARD) and get \$5 eCapitaVoucher. Members who sign up with promo code SPCREWARD and snap their first scanned receipt of minimum \$30 from SPC will be rewarded with additional \$10 eCapitaVoucher. Limited to first 1,000 redemptions. Purchasing of eCapitaVoucher from the CapitaStar App is considered as the first transaction/ purchase and the promotion <New Member Perks> is not applicable to the purchase of eCapitaVoucher .

3. Eligible Shoppers can combine receipts with transactional value of minimum S\$20, with at least one receipt with transactional value of minimum S\$40. Receipts with transactional value of less than S\$20 per transaction are not accepted for this Promotion, to be combined to meet the Qualifying Spend for this Promotion.

4. Eligible Shoppers must snap the receipt(s) through their CapitaStar App on the same day of purchase during the Promotion Period and only approved receipt(s) will qualify for this Promotion.

5. eCapitaVoucher(s) awarded from this Promotion will expire in 93 days from the date of issuance. Eligible Shoppers can visit the "Vouchers" tab on the CapitaStar App main screen for more information on the eCapitaVoucher(s) and the expiry date.

#### General Terms and Conditions:

1. The Reward in this Promotion is provided on a first-come-first-served basis and redemption of the Rewards is subject to availability.

2. The Reward is provided as is and cannot be exchanged for cash. The Reward must be redeemed by the qualifying Eligible Shopper and is not transferable to any other shopper. The Organiser is not obliged to provide a replacement item of equal or similar value once the Reward has been redeemed in full. The Organiser reserves the right to replace the Reward with an item of similar value at any time without prior notice.

3. The Reward cannot be exchanged for different denomination and is subject to the relevant terms and conditions governing the use of the same.

4. There will strictly be no extension for the expiry date of the Reward.

5. Qualifying Eligible Shopper must snap their receipt through the CapitaStar App on the same day of purchase during the Promotion Period. Receipt(s) snapped after the date of purchase will not be accepted.

6. All receipts shall be considered expended for the purposes of this Promotion and any other promotions in the Participating CapitaLand Mall (if any) when it is used to redeem the Reward. Receipts cannot be used for redemption of multiple Rewards. Receipts cannot be used for redemption of more than one promotion at each Participating CapitaLand Mall.

7. The Organiser reserves the right to verify all transactions made by the qualifying Eligible Shopper and the tax invoice(s)/ receipt(s) before processing the redemption of the Promotion.

8. Only the total final amount paid as indicated on the tax invoice(s)/ receipt(s) issued by the participating store(s) will be accepted for redemption under this Promotion. NETS or credit/debit card transaction slips are not acceptable in place of original copies of shopping receipts. Receipt(s) from all car grooming services, Plaza Singapura Gong Cha, Plaza Singapura Aroma Truffle, SingPost transactions, purchase of parking coupons, purchase or top up of Cashcard / stored value cards, purchase or top up of stores' membership card, gift cards and vouchers (i.e. CapitaVouchers/ eCapitaVouchers or participating stores' vouchers), SISTIC transactions, AXS / SAM machines transactions and bill payments, purchase of lottery tickets, purchase of movie tickets and food and beverages at cinema, any transactions at pawn shops and money changer, bank and other financial institutions' transactions, transactions from pushcarts and stalls at temporary roadshow at the Mall are not eligible for use as a receipt in this Promotion.

The Organiser and its partner(s) (if any) in this Promotion reserve the right to change, vary, replace, substitute, amend, withdrawal or cancel this Promotion and/or any of the terms and conditions herein at their sole and absolute discretion and without prior notice or any liability to any party.

11. The Organiser does not make any warranty or representation in relation to any product or services offered in this Promotion or redeemed by vouchers and shall not accept any liability in respect of the same.

13. Without limiting the generality of the above, the following persons shall Not be eligible for the Promotion:
